ACTION AND DATE RECORD

INSTRUCTIONS:The By-Laws require that a Membership Application be filled in and signed by (or in behalf of) an active Member, on a Form approved by the Board of Directors (this Form was approved by the Board of Directors on July 10, 2001); then delivered to the Executive Vice-President; who then shall submit it to the Membership Committee for a timely investigation; and then submission to the Board of Directors with a recommendation for approval or non-approval, together with such other recommendations as the Membership Committee deems appropriate. (Section 1, ARTICLE II) Upon receipt of the Application and the recommendation from the Membership Committee, the Board shall consider the Application at its next regular or specially-called meeting, and shall vote on the same at the next-following regular or specially-called meeting after the meeting at which such consideration takes place.

(Section 1, ARTICLE II) The required vote to approve or disapprove the Application is a majority of those present at a duly-held meeting of the Board, at which a Quorum is present. (Section 1, ARTICLE VIII) A Quorum is six (6) of the eleven (11) voting Members of the Board, including the Executive Vice-President. Following approval of an Application by the Board, the Applicant's name, sponsor, and classification shall be announced at the next regular meeting of the Membership and published in the next weekly publication of the Association, following the meeting of the Board at which approval was received. If no objection is raised by an active Member to the Application within ten (10) days after the mailing of the weekly publication, then the Application shall be deemed to have been approved, and the Executive Vice-President shall notify the Applicant. (Section 1, ARTICLE II) On the other hand, if timely objection is raised to such Application by any (active) Member, the Application must be returned to the Board for reconsideration. Upon such reconsideration, interested Members shall be allowed to present objections to, as well as support for, the Application. After due reconsideration, the Board again shall vote on the Application, and a majority vote again is required to approve the Application. The decision of the Board, upon such reconsideration, shall be final. (Section 1, ARTICLE II)
